This Cookie Policy explains how we use cookies and similar technologies on Size (the "Platform") and how you can control them. It supplements, and should be read together with, our Privacy Policy and Terms of Service. Capitalized terms used but not defined here have the meaning given in our Terms of Service.

1. WHAT ARE COOKIES

Cookies are small text files placed on your device when you visit a website. Similar technologies include pixels, tags, local storage, and software development kits. They let a site function, remember your choices, and understand how it is used. We refer to all of these as "cookies" in this Policy.

"First-party" cookies are set by us. "Third-party" cookies are set by our service providers. We use cookies only on our own Platform. We do not use cookies to track you across other websites or to serve advertising.

2. CATEGORIES OF COOKIES WE USE

Strictly necessary cookies. Required for the Platform to function and to be kept secure, including authentication, session management, security, and enforcement of our Terms and jurisdiction restrictions. These do not require consent and cannot be switched off through our banner.

Analytics and performance cookies. Help us understand how the Platform is used, including which pages and features are viewed, click and interaction behavior, and performance. We use these to improve the Platform. In the EEA and UK these are placed only with your consent.

Functional cookies. Remember your settings and preferences to improve your experience. Where not strictly necessary, these are placed only with your consent in the EEA and UK.

We do not use advertising or cross-site tracking cookies.

Browser controls. Most browsers let you block or delete cookies through their settings. Blocking strictly necessary cookies may prevent parts of the Platform from working.

Analytics opt-out. You can opt out of Google Analytics using Google's browser add-on at tools.google.com/dlpage/gaoptout.

Outside the EEA and UK, we rely on the consent and notification standards applicable in your jurisdiction and in the jurisdiction in which the Company is established.
