Size is a skill-based game, not trading or investing. Trials and Lives are simulated. There is no real trading, no real market execution, and no real financial product. Words like "trade", "profit", and "balance" describe game features only. Simulated capital is owned by us, has no monetary value, and is not your money.

What you spend can be lost and is non-refundable. Keys and other Store items are fees for access. They are not deposits, not investments, and not insured. Once used, they are non-refundable except where the law requires otherwise.

You control your wallet. We cannot. Your wallet is non-custodial. You alone hold and control your keys and approve every transaction. We cannot access, move, freeze, or recover your assets, and we cannot restore your keys. If you lose your login credentials or recovery method, you may lose access to your assets permanently and irreversibly.

Crypto and smart contracts carry risk. Digital assets can be volatile and may lose all value. Blockchain transactions are irreversible. Smart contracts and networks can contain bugs or be exploited, fail, or be attacked. You use them at your own risk.
